Council Member Sabino "Pio" Renteria is a father, community activist, and a lifetime citizen of Austin's District 3. At a very young age he learned the lessons of hard work and serving others. Pio went on to retire from IBM after 34 years of service as a Computer & Printer Technician. Time to Update our Neighborhood Plan Priorities

The City of Austin's Planning and Development Review Department (PDRD) invites Neighborhood Planning Contact Teams to update the priorities identified in their Neighborhood Plans* every three years. The Dawson Neighborhood Planning Contact Team (DNPCT) last updated our priorities in 2012, so the spring of 2015 is our opportunity to assess which recommendations within our adopted plan are most important given the conditions in our neighborhood today. This year the city is asking us to select five Capital Improvement Projects (CIPs) and five non-CIP priorities from a table furnished by the city. Incomplete priority rankings from previous years can be changed during this exercise. This information is utilized in the city's ongoing CIP planning pro-

cess, and it provides a focal point for PDRD's work with other city departments to advance neighborhood-identified projects and programs. In the past 3 years, we have seen the completion of some of the sidewalks we identified as priorities, and, perhaps, 2015 might be the year our sidewalk plan is completed!

Jackie Chuter with PDRD will attend the meeting to lead the process. Expect the survey to take up to an hour.

Learn Emergency Preparedness from CERT

The Community Emergency Response Team (CERT) Program educates people about disaster preparedness for hazards that may impact their area. Using the training learned in the classroom and during exercises, CERT members can assist others in their neighborhood or workplace following an event when professional responders are not immediately available to help. CERT members also are encouraged to support

emergency response agencies by taking a more active role in emergency preparedness projects in their community. The City of Austin has trained more than 1,000 Austin-area residents about how to respond to emergencies and how to be disaster-ready. (Source: CERT brochure)

Training is free and offered twice a year. Once trained, CERT volunteers are asked to educate friends, family,

neighbors and others on preparing for and responding to emergencies, volunteer to make safer communities and maintain their CERT skills.

Sidewalk of Fame

It was a surprise and very pleasing to see a work crew on Cumberland Street a few weeks ago. They were installing an ADA, wheelchair compliant sidewalk along the north side where none existed before. Now it connects South Congress with existing sidewalks.

Cynthia Medlin provided an update at the February Meeting of the Dawson Neighborhood on Sidewalks. (Apparently, we have a small fund from developments for sidewalks, but not enough yet for a feasible project). The section of sidewalk on Cumberland adds to our needed sidewalks identified in the Dawson Neighborhood Plan.

Cynthia has been discussing the Sidewalk funds with city staff and also the safety issue of the particular section of Cumberland. So it should not be a surprise that the work has been going on.

Cynthia is a long standing advocate for neighborhood issues and has a vast knowledge of our history and city planning rules. She was involved in the formulation of the Neighborhood Plan, and we should be very proud to have had her serve as a city Planning Commissioner also. (Current DNA President Myron Smith has also served recently as a Planning Commissioner).

If we had a SideWalk of Fame Cynthia would get the first star.

- 1) The city approved the Residential Parking Permits (RPP) for El Paso between S. 1st and La Mesa and installed the signs in February. The RPP for Post Road is underway.
- 2) It's My Park Day! was a great success. Dawson residents joined Dawson Elementary School teachers, parents and their children, the principal and her son to clean up trash in Gillis Park.

Election of the board: Peter Davis Chair, Marty Harris, Vice Chair, Julie Woods, Secretary. Discussed whether to vote to correct the omission of Chad Cospers in the last meeting's board election and set aside the issue, given his absence. Chair opened discussion of the Front yard Parking ordinance. Chad V. proposed a friendly amendment to the ballot, which was voted to be tabled as not permitted under current COA requirements. Cynthia Medlin shared an update re. Priority Sidewalk program with COA. Discussion of the Parking Permit Zone on El Paso between 1st Street and LaMesa. Results of the Front Yard Parking ordinance vote announced: 9 in favor, 13 against, with 2 abstentions and 2 blanks. Ordinance not adopted by the DNPCT.
