Proposal to Eliminate the Feb/July Plan Amendment Window

On January 13th Margaret Valenti notified contact teams that the Neighborhood Planning Staff would ask the Planning Commission's (PC) Codes & Ordinances Subcommittee to eliminate the February and July application submittal window in the neighborhood plan amendment process. Staff argued that the process is inefficient and this change would benefit contact teams. Instead, allowing submittals year round created controversy and caused great concern for most contact teams.

Staff claims it sent a survey to contact teams on April 29, 2011 asking for input on the proposed changes. Only 27 out of 400+ recipients participated, so staff assumed the low response indicated that contact teams had no preference on the issues. Contact teams posted messages on the Austin Neighborhoods Council's listserv and contacted staff to make it clear that most were not aware of the survey or this proposal. Overall, most contact teams believe that removing the window will both create a lot more work for volunteers already burdened by the process and benefit staff and applicants rather than neighborhood

At its January 17th meeting, the Codes & Ordinances Subcommittee did not initiate this change but, instead, directed staff to present the proposal to the PC's Neighborhood Plan Subcommittee on Feb 15th at City Hall, 6:00pm, Executive Session Room. Euclid-Wilson Storm Drain Project Update

The City of Austin Public Works Department will soon begin work on the Euclid-Wilson project. The work will include installing storm drains, water lines, and curbside inlets in the area bordered by Oltorf, S. Congress, Cumberland and S. 1st. The project's goal is to reduce the potential for localized flooding of houses, streets and yards due to an overloaded storm drain system. McClean Construction is the contractor for this project. The expected completion is December 2013 but that date and the overall schedule are subject to change.

Beginning in January, there will be lane closures on Oltorf. The original construction schedule called for these closures to start in February; however, the schedule has been modified to prevent traffic congestion on major roads during the SXSW Festival. In order to make progress during this time, in mid-February the contractor will begin installing storm drain junction boxes at the intersections of Oltorf at Wilson and Forest. At the same time, the contractor will begin installing storm drains and relocating water and wastewater on Durwood and Wilson.

As the project progresses, there will be additional lane closures on S. 1st, S. Congress, Cumberland and neighborhood streets. The agreement with the City allows the contractor to work from 7 am to 7 pm on weekdays and weekends. Thank you for working to help keep children away from the construction area and equipment.

Crow Bar Owners Host Meeting with Area Neighbors

On January 16th, APD District Representative Robert Barboza facilitated a meeting between the Crow Bar owners, Mike & Steve, their supporters & area residents searching for a solution to problems they feel are caused by the bar & its patrons. The primary complaints are patrons parking in the neighborhood rather than in the bar's overflow parking, noise from patrons especially when leaving the bar, public urination, trash such as beer cans, condoms & needles, & car burglaries/vandalism. Officer Barboza pointed out that some problems, such as car burglaries & trash associated with prostitution & homeless camps, are city-wide problems & cannot be attributed to the Crow Bar. Plus, other longtime nuisance businesses nearby (i.e., by-the-hour motels) contribute to these problems. After discussion on both sides of the issue, Mike & Steve agreed to work even more aggressively to stop patrons from parking in the neighborhood & to provide escorts at closing time to encourage patrons to please be quiet as they leave. Area residents will also continue pursuing Residential Parking Permits (RPPs) to limit parking to permitted vehicles only. Most attendees seemed satisfied at the end of the meeting.
