### **Guinea Fowl in the Neighborhood**



Animal lovers in the neighborhood have been enjoying the presence of a small flock of guinea fowl in the area around the Brinwood Avenue area. We were especially charmed by the 12 or so baby chicks that appeared in the spring. Sadly, the number of chicks has decreased steadily since. Around the first of June, there were at least 5 adults and 8 chicks. though the birds do not always cooperate with efforts to track their numbers. As of the week of July 20, there seems to be only 5 guineas remaining: 3 adults and 2 of the young birds.

Some of the folks in the Brinwood area have discussed how to protect the birds since at least three of the adult birds have been found in the street, apparently struck by a car. The city has committed to help and has provided several signs warning the cars to slow down.

Guineas are interesting birds, with grey speckled feathers and white, featherless faces, a pointed "helmet" and red wattles. Native to Africa, they are noisy and relentless foragers, eating bugs and small snakes and lizards while leaving most plants alone. Farmers like to keep them around because they are more self-sufficient than chickens, keep the bugs under control (they are especially effective against ticks) without tearing up seedlings and will chase away dangerous snakes like rattlers. While they are domesticated fowl like chickens or turkeys, guineas have resisted efforts to breed a more friendly temperament or more consistent egg-laying. They are also much better flyers than chickens, though their preferred activity is searching for food on the ground.





Minutes of the April meeting were approved as printed in the newsletter. Guest: Officer Robert Barboza gave a presentation and answered questions. The meeting adjourned at 7:15 p.m. Sandy McMillan, Secretary

#### **DNPCT Meeting Draft Minutes, June 8, 2015**

Minutes approved as written in the newsletter. Membership report, new members welcomed. Mike McHone and spoke about the hotel to be built on S. Congress in the location of the Taste of China restaurant. Concerns re. impervious cover and flooding discussed. The plan team will have to approve a variance re. fire lane but not anytime soon. Presentation from Crux Climbing Center at 2100 Pickle Road; no plan team action required. Neighbors' concerns re. parking and impervious cover seem to be taken into account; facility will open around January 1, 2016. Meredith Berman spoke about the Infinite Money Theorem winery, to be in the same building as the climbing gym. Most of the space will be manufacturing and the property is zoned for light manufacturing. The presence of the tasting room requires a conditional use permit since it's located close to SF properties (but city code doesn't require the same setbacks and zoning as a bar). The winery is hoping to be running by late July or August, with the conditional use permit to follow. Currently the entrance will be on Pickle only; using the Lessin entrance will be an option but not a desirable one. Neighbors expressed concerns re. parking, traffic and noise and were assured that these concerns will be addressed. Quick discussion of the surveys, both the city's and the DNA/Plan Team.
